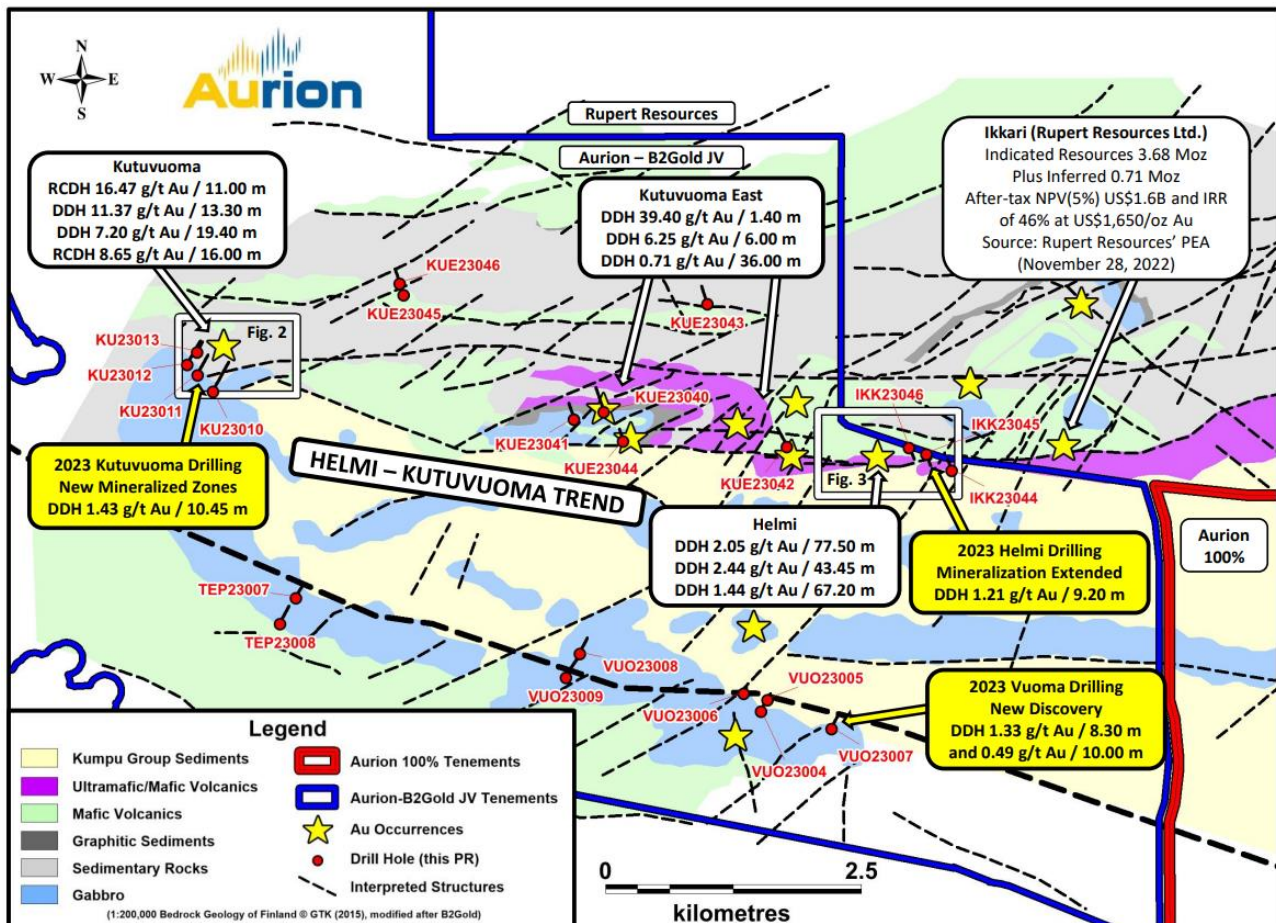

# Industry News

**Aurion Resources** announced the discovery of a new zone of gold mineralization several kilometers south of the previous Helmi discovery, returning 1.33g/t Au over 8.3m in drill hole VUO23007. Notably, the new mineralization (“Vuoma”) was discovered by drill testing the less explored southern contact of the Kumpu basin that is known to host gold mineralization (e.g. Helmi) along its northern boundary.

Drilling further resulted in the extension of mineralization at the Helmi discovery as well as in the identification of new mineralized zones south of the Kutuvuoma prospect, returning e.g. 1.43g/t Au over 10.45m.

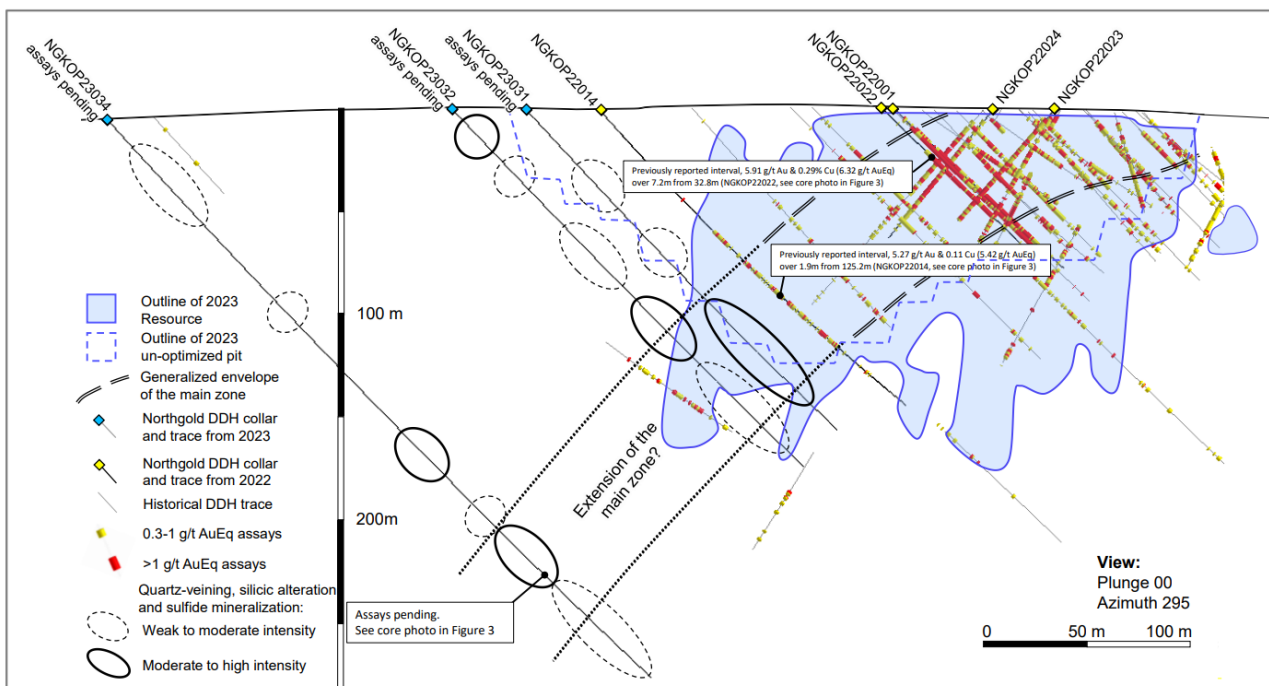
For the second half of 2023, the B2 Gold – Aurion JV aims to drill a total of 4500m, following up on newly identified mineralized zones and testing additional targets.

**Northgold** reported promising visual results from recent drilling at its Kopsa flagship project. Drill hole NGKOP23034, the deepest hole completed in 2023, returned two intervals of intense quartz veining and/or silicic alteration with sulfide mineralization for a combined width of 63m. While assays are currently pending the mineralized intervals appear similar to previous high-grade intersections in drill holes NGKOP22022 (5.91g/t Au, 0.29% Cu over 7.2m) and NGKOP22014 (5.27g/t Au, 0.11% Cu over 1.9m).

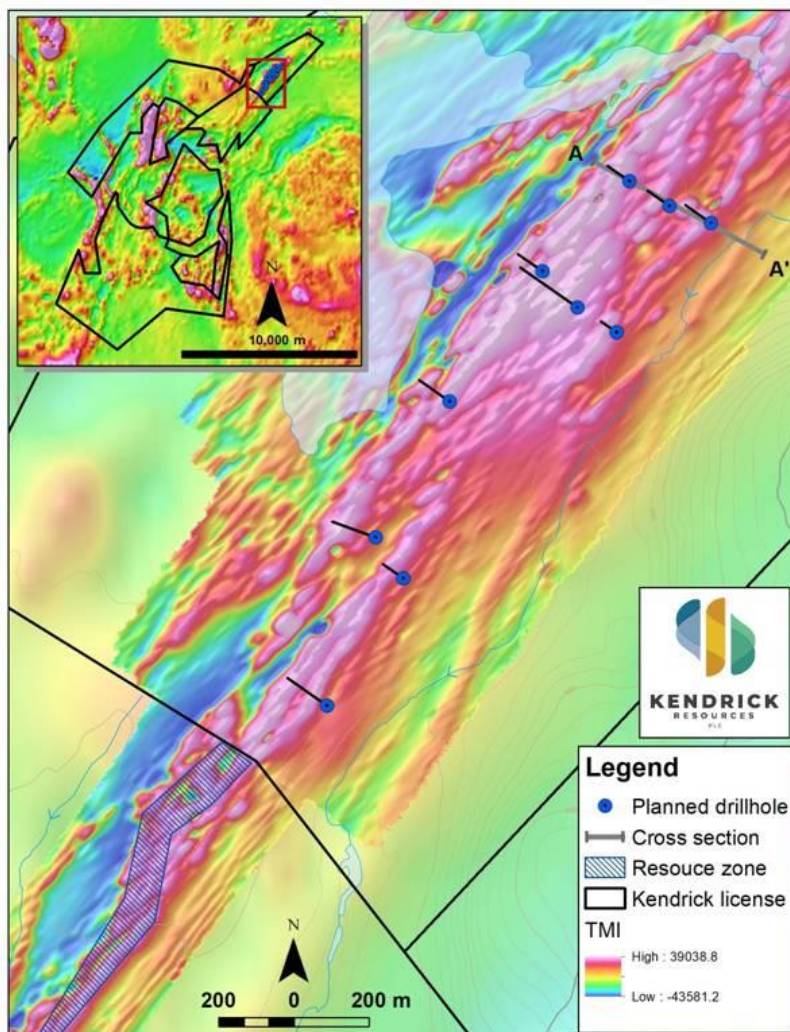


Cross section looking W-NW showing the 2023 Kopsa resource, un-optimized pit outlines, and drilling data

**Kendrick Resources** provided an operational update on its Swedish projects. A 1500m diamond drilling program commenced at the company's Airijoki Vanadium project. The program aims to grow the existing JORC-compliant inferred resource (44.3Mt @ 0.4% V<sub>2</sub>O<sub>5</sub>) by testing the prospective strata further to the NE. In addition, the company recently completed a large-scale Ionic leach soil sampling program over the recently awarded Airijoki 104 & 105 licenses, with results currently pending.

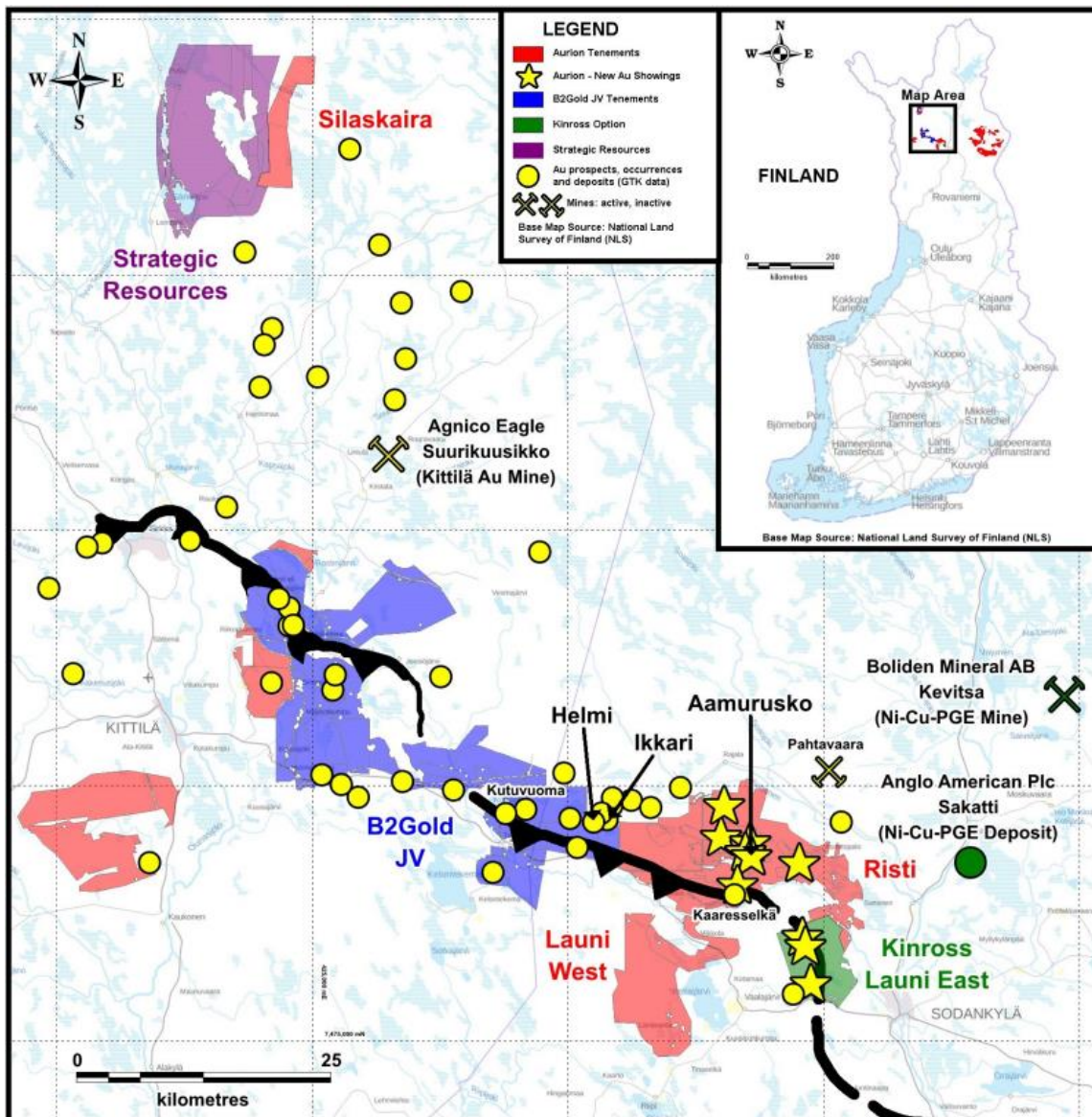
An ionic leach soil sampling program was further completed on the recently acquired Mjövattnet Ni project, targeting the strike extension and surrounding areas of the Lappvattnet deposit.

**Aurion Resources** signed a definitive option agreement with Kinross Gold regarding the Launi East property. Under the agreement, Kinross can earn 70% in the property by spending a minimum of 10 million USD before the 7<sup>th</sup> anniversary of the agreement. The company further advised the termination of the Silaskaira option agreement with Kinross.
